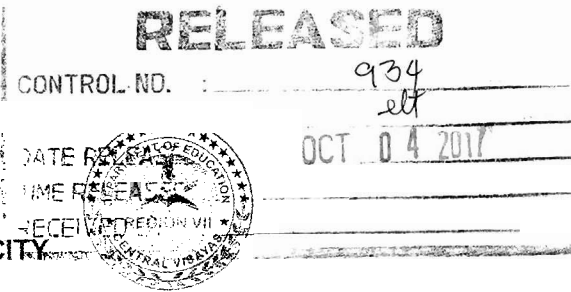



Your kind gesture would surely help me ease my financial burden. Thank you very much and may God continue to bless us all with good health.

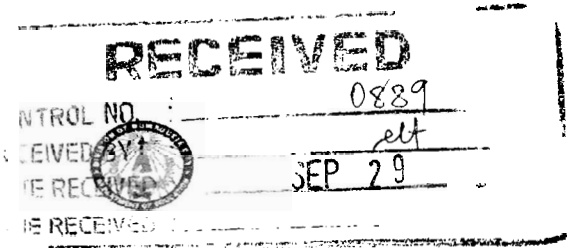


