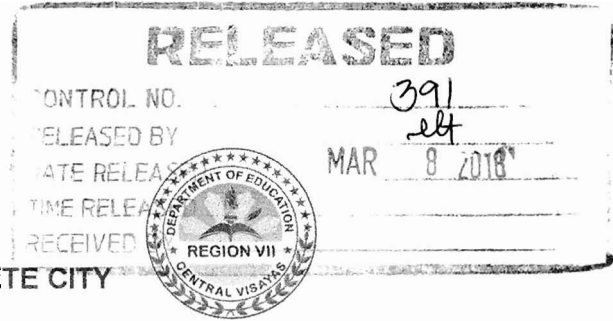



Once again, we will be conducting the Career Service Examination come **March 18, 2018** in Dumaguete City.




