**INVITATION TO BID**

The Department of Education, Division of Dumaguete City, intends to apply the sum of Philippines Peso Six Hundred Thirty Nine Thousand Pesos only (Php 639,000.00) being the Approved Budget for the Contract (ABC) to payments under the contract for the works described below for the various schools in the Division of Dumaguete City as follows:

The Department of Education, Division of Dumaguete City, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Bids received that exceed the total ABC shall be rejected at bid opening. Bidder may bid for one or all items. Late bid shall be rejected. Evaluation and award shall be made on a per item basis.

Prospective bidders must have completed a similar contract within the last ten (10) years from date of submission and receipt of bids with an amount of at least 50% of the ABC to be bid.

Bidding is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.


Open competitive bidding will be conducted using the non-discretionary pass/fail criterion, evaluation and post-qualification procedures specified in the Implementing Rules and Regulations (IRR) of RA 9184. Information is also available at [www.philgeps.gov.ph](http://www.philgeps.gov.ph).
