Each contestant must be in his/her best Pilipino costume either from Luzon, Visayas or Mindanao. c. No vulgar attire d. Judges decision is final and irrevocable. B. Criteria Adherence to the place being represented 40% Creativity (Mix and Match Accessories) - 30% Appropriateness of the Outfit - 20% Overall Appeal - 10% TOTAL 100%
Pinakamahusay sa Pagtutula (Malaya)	 A. Mechanics a. Each office will have representative (s). b. All contestants will be given a uniform contest piece. c. Contestants are given 5 minutes to prepare and deliver the piece in 3 minutes. d. Contest pieces may or may not be brought by the contestants upon delivery. e. Judges decision is final and irrevocable. B. Criteria Mastery of the Piece - 25% Delivery - 40% Gestures/Facial Expression - 35% TOTAL 100%
Pagsalin (Filipino Sign Language)	 A. Mechanics a. Each office will have representative (s). b. A video presentation on the use of Filipino Sign Language (FSL) will be presented and simulation will follow. c. Contestants with higher number of correct interpretations will be declared winner. d. Judges decision is final and irrevocable.
