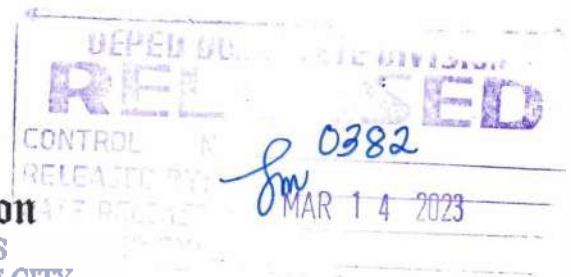

The Department of Education recognizes the importance of promoting cultural awareness and exposing the learners to performing arts in their holistic development. This is why the DepEd's Arts and Design track in Senior High School aims to lead their interest and talents to the path of creativity and contribution to innovative nation-building.

Since face-to-face classes and activities in schools are currently on hold, the plan of the Philippine Mobile Music and Theater Productions Co. (PMMTPCo) to conduct the shows virtually is most fitting. DepEd may cross-post the virtual shows on the DepEd Philippines Facebook Page, upon request.

Please be informed of the following guidelines that DepEd employs in the conduct of shows or similar activities:

1. Participation of public and private schools in the activities shall be subject to the **no disruption of classes policy** stipulated in DepEd Order No. 9, s. 2005 titled Instituting Measures to Increase Engaged Time-on-Task and Ensuring Compliance Therewith, and the policy on off-campus activities stated in DepEd Order No. 66, s. 2017.
2. Conduct of live performances shall be subject to the IATF guidelines on face-to-face activities. Also, all activities shall be subject to the **no-collection policy** under Republic Act No. 5546 also known as An Act Prohibiting the Sale of Tickets and/or the Collection of Contributions for Whatever Project or Purpose from Students and Teachers of Public and Private Schools, Colleges and Universities, which states:





Sec. 1. The sale of tickets and/or the collection of contributions in any form whatsoever, by any person for any project or purpose, whether voluntary or otherwise, from school children, students and teachers of public and private schools, colleges and universities is hereby prohibited: *Provided, However,* That this prohibition shall not cover membership fees of school children and students in the Red Cross, the Girl Scouts of the Philippines and the Boy Scouts of the Philippines: *Provided, Finally,* That this prohibition shall not cover the contributions of parents and other donors for the support of barrio high schools."

**AN ORDER ALLOWING THE CONDUCT OF IN-PERSON ACTIVITIES IN SCHOOLS**

To: Undersecretaries  
Assistant Secretaries  
Bureau and Service Directors  
Regional Directors  
Minister, Basic, Higher and Technical Education, BARMM  
Schools Division Superintendents  
Public Elementary and Secondary School Heads  
State/Local University and College Heads  
All Others Concerned

1. In line with the commitment of the Department of Education (DepEd) to deliver quality basic education in a safe learning environment to learners, this Order is issued for the guidance of learners, personnel, parents, guardians, and other stakeholders relative to the conduct of in-person school activities.

2. For the safe resumption and reintroduction of the conduct of in-person school activities, consistent with the public health standards of the government in light of COVID-19, the following guidelines shall be observed:

- a. **Curricular and co-curricular activities that involve the in-person gathering of a number of participants shall be allowed.** Curricular activities shall be conducted during the academic quarter to ensure that learners can seamlessly connect and integrate learning within and across learning areas. On the other hand, co-curricular activities shall be conducted after the quarterly examinations to avoid disruption of classes.
- b. Item 33 of DepEd Order No. 034, s. 2022 dated July 11, 2022, provides that: The conduct of extra-curricular activities shall be strictly prohibited. However, it must be clarified that only those extra-curricular activities held during class hours are prohibited. The conduct of in-person extra-curricular activities shall be allowed, provided that these activities are conducted after class hours.

3. Public Schools must ensure the strict observance of these guidelines during the conduct of in-person curricular, co-curricular, and extra-curricular activities.

4. Private schools, community learning centers, as well as state/local universities and colleges (SUCs/LUCs) may choose to adopt the provisions of this DO as basis in the conduct of in-person curricular, co-curricular, and extra-curricular activities.

5. This Order shall take effect upon posting on the DepEd website. It shall also be filed with the University of the Philippines Law Center (UP LC)-Office of the National Administrative Register (ONAR), UP Diliman, Quezon City.
6. Immediate dissemination of and strict compliance with this Order is directed.
